

## **Electrical Utility Lineman Training Program Application**

This program is designed to prepare workers for the electrical power transmission and distribution industry.

Class dates: January 8, 2024- May 2, 2024 (16 weeks)

**Location** – MDCC, Moorhead, MS **Class times** – 7:30 am - 5:30 pm, Monday – Thursday

# Applications will be accepted October 2, 2023 – November 2, 2023 Incomplete and/or late applications will not be considered.

Space is limited. Make sure your application is **complete and submitted** by the above deadline.

## What you will learn over 16 weeks of training

- Drive commercial vehicles with automatic and <u>standard shift transmission</u>, maneuver, back up, and park a trailer
- Explain all aspects of the APPA Safety Manual
- Make connections of meter loops, transformers, and other equipment on de-energized poles
- Assist with the framing and installation of utility poles and apparatus on the ground
- Read and understand general information in the REA spec book
- Assist in the burying of cable and other related work
- Safely operate vehicles and equipment (bucket trucks, digger derrick trucks, etc.)
- Differentiate between an energized and de-energized structure and recognize hazards
- Make basic connections and disconnections
- Check voltage/amperes

#### **Cost for Training**

**Mississippi Residents:** Tuition/cost funding is provided and paid for through a Delta Workforce Development Area (DWDA) grant and the Workforce Office of Accelerate MS; it is available for in-state residents only. This funding will be available each year the grant is renewed.

**Out-of-State Residents**: Tuition is \$3,200.00 plus an optional \$2,400 for campus housing and the weekend cafeteria plan. **Out-of-State residents must provide their own boots.** 

#### **Admission Requirements**

All electrical utility lineman trainee applicants must:

- Be at least 18 years of age
- Earn a minimum <u>Silver Level National Career Readiness Certificate (NCRC)</u>. The test is given by appointment at the Capps Center in Indianola, other community colleges, and MDES WIN Job Centers . You must earn the NCRC prior to the application deadline of <u>November 2, 2023</u>. To preregister for scheduling in Indianola, Cleveland, Greenwood, or Greenville, please complete the form at this link: <a href="https://msdelta.formstack.com/forms/crc">https://msdelta.formstack.com/forms/crc</a>. If you do not live close to these areas, please contact your local community college and/or MDES WIN Job Center.
- Obtain a Mississippi CDL Class A permit with Air Brakes. The permit requires a certified D.O.T.
   Physical prior to November 2, 2023. The costs for the MS CDL Class A Permit and physical are not reimbursed by the grant.
- D.O.T drug screen dated anytime between October 2, 2023 to November 2, 2023. The cost for the D.O.T drug screen is not reimbursed by the grant.
- Request a MS Motor Vehicle Report from the Mississippi Department of Public Safety at <a href="https://www.ms.gov/dps/license\_renewal/MVR">https://www.ms.gov/dps/license\_renewal/MVR</a> (must be dated between October 2, 2023 to November 2, 2023)
- Provide a copy of each of the below:
  - An official copy of high school diploma or accredited GED certificate <u>OR</u> latest college transcript
  - 2. Valid MS Commercial Driver's License Class A Permit (front and back) and a Copy of D.O.T Physical
  - 3. D.O.T Drug Screen (negative)
  - 4. Social Security card
  - 5. MS Motor Vehicle Report
  - 6. Copy of National Career Readiness Certificate (NCRC) including results from each exam.

Please DO NOT send original medical examiner's certificate and medical exam report form. We will not be responsible for returning any original documents needed to earn the CDL.

\*NOTE: It is your responsibility to ensure all documents are received; failure to provide all documents will result in an INCOMPLETE APPLICATION. Applications received after November 2, 2023 will not be considered.

	Ability to sit for a minimum of two to three hours – may be driving a truck.
	Ability to move frequently to unload equipment and to install/maintain/repair equipment.
	Ability to lift up to 75 pounds.
	Ability to push/pull weights up to 100 pounds.
	Ability to frequently climb and use authorized equipment to reach various heights and breadths.
	Ability to frequently and repetitively bend/stoop/squat.
	Ability to differentiate between colors (color vision).
	Ability to learn through classroom instruction, training and repetitive motions.
	Ability to recognize hazards during training and have the ability to mitigate the hazards.
	Ability to maintain and care for school equipment properly and safeguard assets.
	Manual dexterity to operate small hand tools, turn small knobs, etc.
	Ability to work comfortably at various heights up to 65 feet, without anxiety or fear, with both
	hands free, depending only on your climbing hooks and safety harness for support.
	Ability to meet the public in a pleasant and tactful manner and understand the importance of you
	representing MDCC during any sanctioned events, field trips, and while on campus.
	Must adhere to all MDCC student policies, pay traffic fines timely, and pay any other charges to the
	Business Office as agreed upon. You will not graduate or receive your certificates and/or
	credentials if you owe MDCC at the time of graduation.
