IMPORTANT DATES TO REMEMBER

Fall 2020 (Regular Session)

Classes begin August 24, 2020

Drop/Add..... August 24-25, 2020

Charges will be incurred after the NO Show Date September 9, 2020
(A student is considered a “No Show” if there is no documentable engagement with the course content within the timeframe allowed.)

Your MDCC instructor will designate weekly attendance markers. You are allowed 2 absences (missing 2 attendance markers) in the regular session classes; therefore, on your 3rd absence you will be cut from the course. Be sure you understand the instructor’s policy if taking a course from another school.

Mid-term exam proctored dates October 8, 12-15, 2020
(Check the eLearning web site for times and locations. For a non-MDCC course, check your syllabus for dates).

First day a MDCC student may withdraw from a MDCC course October 24, 2020

Last day to withdraw from online courses affecting other schools.... November 6, 2020

Last day a MDCC student may withdraw from a MDCC course November 18, 2020
(Student may NOT take the final exam and withdraw).

Final exam proctored dates November 19, 23-25, & 30, Dec 1-3, 2020
