### Spring 2020 (Regular Session)

Classes begin .....January 13, 2020  
Drop/Add.....January 13-14, 2020  
Charges will be incurred after the NO Show Date .....January 26, 2020  
(A student is considered a “No Show” if there is no documentable engagement with the course content within the timeframe allowed.)

**Your MDCC instructor will designate weekly attendance markers. You are allowed 2 absences (missing 2 attendance markers) in the regular session classes; therefore, on your 3<sup>rd</sup> absence you will be cut from the course. Be sure you understand the instructor’s policy if taking a course from another school.**
